The above foreign currency budget rates are based on PBD 660, dated December 9, 2002. **Adjusting exchange rates for the individual euro-area currencies are no longer provided. ${ }^{* * *}$ On January 31, 2004, the Government of Turkey passed a law to redenominate its currency from the Turkey Lira (TL) to the New Turkey Lira (YTL). Starting January 1, 2005, Turkey will be dropping six zeros off of the Turkey Lira (TL). This means that 1 million TL will now be equal to 1.0 YTL. To coincide with the change, Turkey will issue new currency. Both the new and old currency will be in circulation for all of 2005. The old currency will no longer be valid after December 31, 2005.
